Dear Parents,

As you know, Community Consolidated School District 93 utilizes an electronic residency verification process for all CCSD93 students. As described in Board Policy 705.07, students who attend CCSD93's schools must reside within the district's boundaries. Verifying residency helps us to protect district taxpayers by ensuring that resources are spent only on students who live within CCSD93's community.

You are receiving this message to inform you that your residency within CCSD93's boundaries unfortunately could not be verified electronically. As a result, you are required to provide documentation to verify that you are a resident within CCSD93's boundaries before your child can register for, or attend school in, CCSD93 next school year. Enclosed with this message is the Residency Form, which provides a list of the necessary documents that must be provided in order to verify residency.

In order for your child to attend school in CCSD93 next year, you must verify your residency at CCSD93's District Office (230 Covington Drive, Bloomingdale, IL 60108). Please note the following:

- Visit CCSD93's District Office between 8:30 a.m. and 4 p.m. Monday through Thursday between May 27 and July 31.
- Or, the following additional select times, dates, and locations are available instead throughout the summer as an added convenience for you to verify residency:
 - Tuesday, June 18, 3-7 p.m. - Carol Stream School
 - Tuesday, June 25, 3-7 p.m. - Elsie Johnson School
 - Tuesday, July 9, 3-7 p.m. - Western Trails School
 - Saturday, July 20, 9 a.m.-12 p.m. - District Office
 - Tuesday, July 23, 3-7 p.m. - Heritage Lakes School
 - Thursday, July 25, 3-7 p.m. - Cloverdale School
 - Saturday, July 27, 9 a.m.-12 p.m. - District Office
 - Tuesday, July 30, 3-7 p.m. - Roy DeShane School
 - Tuesday, August 6, 3-7 p.m. - Jay Stream Middle School
 - Thursday, August 8, 3-7 p.m. - Stratford Middle School
- Your verification will not take more than 15 minutes.
- **Please bring the documents listed on the enclosed Residency Form with you to your appointment.**
- If you reside in another person's home within CCSD93's boundaries, the owner of the property must also attend the residency verification meeting and bring the appropriate documents listed on the Residency Form.
- Your student will not be allowed to begin the school year in CCSD93 until residency is verified.

Although we regret this initial inconvenience, we recognize that you join us in our commitment to protecting our educational resources so that we can provide the very best learning opportunities for the children who live in our district. Estimados padres,

Como saben, el Distrito escolar consolidado de la Comunidad 93 utiliza un proceso de verificación de residencia electrónica para todos los estudiantes de CCSD93. Como se describe en la Política de la Junta 705.07, los estudiantes que asisten a las escuelas de CCSD93 deben residir dentro de los límites del distrito. Verificar la residencia nos ayuda a proteger a los contribuyentes del distrito al garantizar que los recursos se gasten solo en los estudiantes que viven dentro de la comunidad de CCSD93.

Usted está recibiendo este mensaje para informarle que su residencia dentro de los límites de CCSD93 desafortunadamente no se pudo verificar electrónicamente. Como resultado, debe proporcionar documentación para verificar que usted es residente dentro de los límites de CCSD93 antes de que su hijo(a) pueda matricularse o comenzar la escuela de CCSD93 durante el año escolar siguiente.  - Sábado, 20 de julio, de 9 a.m.-12 p.m. - Oficina del Distrito
 - Martes, 23 de julio, de 3 a 7 p.m. - Escuela Heritage Lakes
 - Jueves 25 de julio, 3-7 p.m. - Escuela Cloverdale
 - Sábado, 27 de julio, de 9 a.m.-12 p.m. - Oficina del Distrito
 - Martes 30 de julio, 3-7 p.m. - Escuela Roy DeShane
 - Martes, 6 de agosto, 3-7 p.m. - Escuela Media Jay Stream
 - Jueves 8 de agosto, de 3 a 7 p.m. - Escuela Secundaria Stratford
- Su verificación no durará más de 15 minutos.
- Por favor traiga a su cita los documentos que figuran en el Formulario de Residencia adjunto.
- Si usted reside en el hogar de otra persona, dentro de las fronteras de CCSD93, el dueño(a) de la propiedad tiene que asistir a la reunión de verificación de residencia y traer los documentos apropiados listados en el Formulario de Residencia.
- No se le permitirá a su estudiante comenzar el año escolar hasta que se verifique la residencia.

Aunque lamentamos este inconveniente inicial, reconocemos que se une a nosotros en nuestro compromiso de proteger nuestros recursos educativos para que podamos brindar las mejores oportunidades de aprendizaje para los niños que viven en nuestro distrito.
