Student Privacy

- I will not give out personal information such as my address, telephone number, parents' work addresses/telephone numbers, or the name of my school without my parents' permission.

- I will never agree to get together with someone I "meet" online without first checking with my parents. If my parents agree to the meeting, I will be sure that it is in a public place and bring my mother or father along.

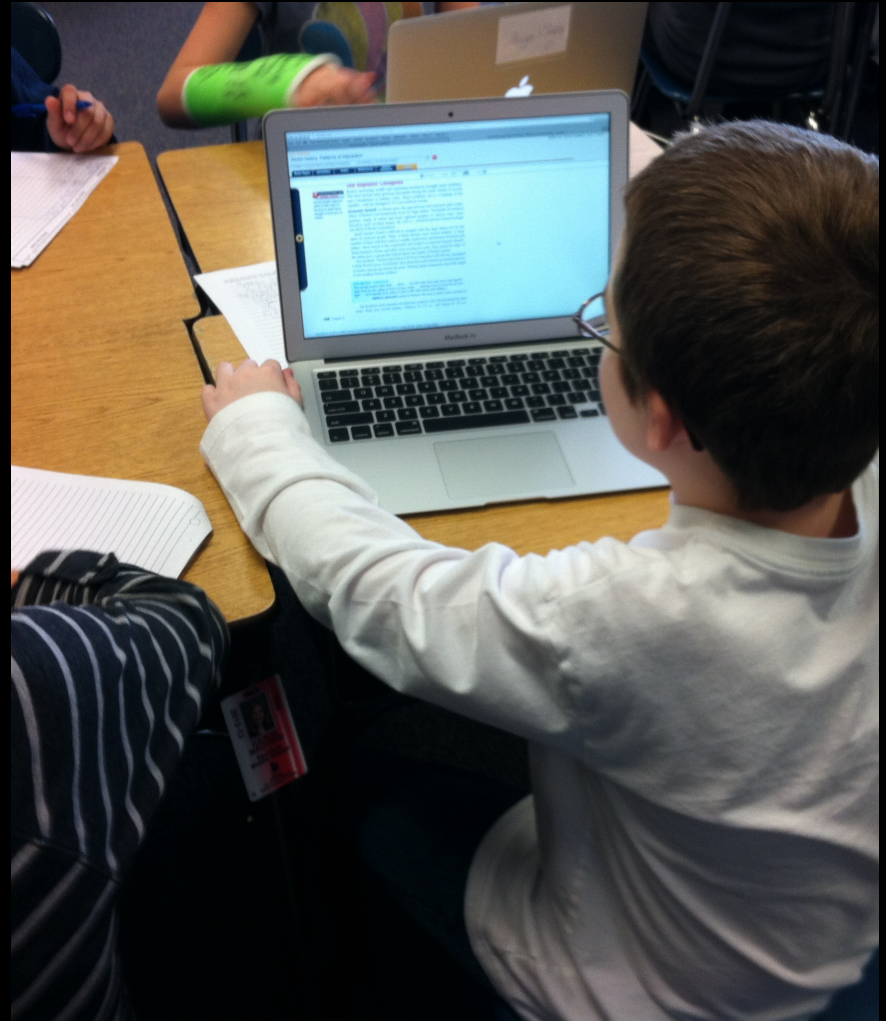
Coppa Law

“COPPA imposes certain requirements on operators of websites or online services directed to children under 13 years of age, and on operators of other websites or online services that have actual knowledge that they are collecting personal information online from a child under 13 years of age.”

What does it mean?

- Children under 13 can not have the following
 - Facebook
 - Apple ID*
 - Twitter
 - Email*
- Make sure you read the terms and conditions



Facebook's T&C

Registration and Account Security

Facebook users provide their real names and information, and we need your help to keep it that way. Here are some commitments you make to us relating to registering and maintaining the security of your account:

- 1 You will not provide any false personal information on Facebook, or create an account for anyone other than yourself without permission.
- 2 You will not create more than one personal account.
- 3 If we disable your account, you will not create another one without our permission.
- 4 You will not use your personal timeline primarily for your own commercial gain, and will use a Facebook Page for such purposes.
- 5 *You will not use Facebook if you are under 13.*

Acceptable Use

Yes, I Can...

- use search tools, websites and educational games provided by my teacher or District 93
- have my parents help me troubleshoot on my device
- give credit when I use pictures and information from the Internet
- keep my full name, image and personal information private online
- tell an adult when something makes me uncomfortable online

Acceptable Use

No, I Cannot...

- access inappropriate websites
- download without permission
- share my device, even with family
- use my device to say or create something hurtful or mean
- post anonymous messages
- log in as someone else
- share my passwords with anyone but my parents or teacher
- click on banner ads

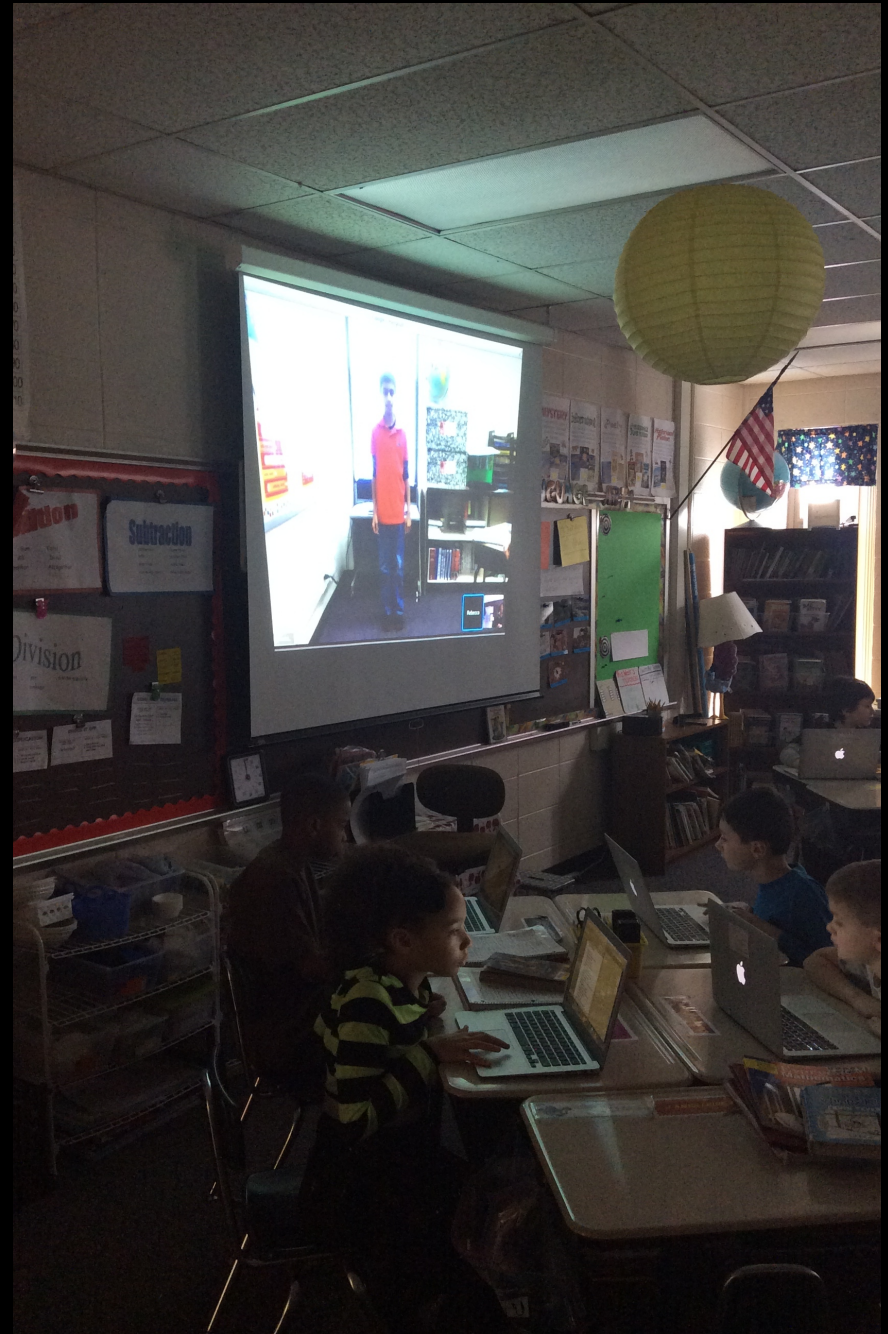
