



# CCSD93 8<sup>th</sup> Graders Invited to Purchase MacBook Air Computers for \$200



Community Consolidated School District 93 graduating 8<sup>th</sup> graders will have the option to purchase District-owned MacBook Air laptop computers for \$200. Participating 8<sup>th</sup>-grade students will purchase a three-year old Macbook. For most students, this will be the same computer that they are currently utilizing. *Please note there is a limit of one computer for each 8<sup>th</sup> grader, and they will be sold in the condition that they are returned to CCSD93.*

## What's included?

### This Purchase Will Include:

- o MacBook Air computer
- o Protective Sleeve
- o Charging Cord

### This Purchase Will Not Include:

- o Licensed curriculum software
- o Microsoft Office

## Payment Options

If you wish to purchase a MacBook Air for your 8<sup>th</sup> grader, please select one of the following payment options.

### \_\_\_\_\_ One-Time Payment:

A one-time payment of \$200 will be due by May 17, 2019

### \_\_\_\_\_ Three-Month Payment Plan:

Three equal monthly installments of \$66.66 will be due by the 15<sup>th</sup> of April, May & June

### \_\_\_\_\_ Five-Month Payment Plan:

Five equal monthly installments of \$40 will be due by the 15<sup>h</sup> of April, May, June, July & August.

### \_\_\_\_\_ Personalized Payment Plan:

All payments will be accepted at your child's middle school until Friday May 24, 2019 and payments thereafter will only be accepted during office hours at the District Office (230 Covington Drive in Bloomingdale). Cash or check payments will be accepted, and you may make payments in person or via US Mail.

## Computer Pickup

Parents selecting the One-Time Payment Plan or Three-Month Payment Plan can pick up their MacBook on June 11 between 9 a.m. and 1 p.m., or June 12 between 3 and 7 p.m.

Parents selecting the Five-Month Payment Plan can pickup their MacBook at a time to be determined in August.

Parents selecting a Personalized Payment Plan will work with CCSD93's Business Office to determine a payment schedule and pickup date.

**Purchase Agreement**  
**for a Used MacBook Computer**

The District agrees to sell to the Purchaser and the Purchaser agrees to purchase from the District, the three (3) year old used MacBook Computer that the student has been using, with accompanying carrying case and power cord for Two Hundred and No/100 Dollars (\$200.00). This Agreement applies only to used MacBook Computers that are three (3) years old. If the student is using a computer that is less than three (3) years old, the student will be purchasing a three (3) year old used MacBook Computer (rather than the newer computer that was issued to the student). The MacBook Serial Number for the Computer being purchased hereunder is:

2. Possession of the Computer will be transferred to the student on the last attendance day of this school year.

3. The Purchaser agrees to purchase the Computer in "as-is" condition and with the understanding that the District is selling the Computer without any warranties, express or implied.

4. The Purchaser acknowledges and agrees that the District is not responsible for any problems with the Computer, including but not limited to malfunctions or damage, once the Purchaser has taken possession of the Computer.

5. The Purchaser also acknowledges and agrees that all licensed software will be removed from the Computer by the District, prior to delivery of the Computer to the Purchaser.

6. Purchaser further acknowledges and agrees that all sales are final, and that Purchaser may not, under any circumstances, return the Computer to the District or obtain a refund.

7. The District represents and certifies that the Computer will be transferred to the Purchaser free from all liens and encumbrances.

8. The Purchaser hereby certifies that the Computer has been inspected by the Purchaser and is acceptable to the Purchaser.
